Some of the highlights of 2018-2019 include developing our three-year strategic plan in May and hosting a Member Refuge Networking event in July. We have a clear direction of how we will build on the strengths of our organisation and in doing so deliver for members and the women and children they support.

Treasurer's report

Year ended 30th June 2019

As the Combined Women's Refuge Group of southeast Queensland enters its 41st year of operation, members report that they are busier than ever. In my last Treasurer's report, I spoke about the horror month that we had had in October 2018 with 10 women killed in Australia by their intimate partner or family member. Not much has changed with these homicide statistics with September 2019 very closely mirroring the death toll in October 2018, with nine women being killed in this month alone. The community always appears to be shocked at these homicide statistics but as Our Watch suggests, until actions are taken to 'reduce the gendered drivers of violence against women', these statistics will not change.2 CWRG can have a real role in advocating for women affected by domestic and family violence and in working together with other stakeholders, work towards addressing the necessary actions that need to be implemented to invoke real change.

Income and expenditure

Australia's CEO Challenge has ensured that the CWRG has been able to remain financially viable. In the last financial year, they paid out \$8272.62 towards wages for our Secretariat.

Memberships yielded a total of \$4700. We would like to say a massive thank you to Australia CEO's Challenge for their financial support. The CWRG spent many years operating on the smell of an oily rag, using market stalls, sausage sizzles and raffles to stay afloat. It is wonderful that we have now have the capacity to use our funds for other projects.

In appreciation

In February this year we farewelled our long term Secretariat, Liz MacDonald. Liz's contribution to the CWRG over many years has been outstanding. Her organisational skills, competency and hard work has largely contributed to the successes that the CWRG has enjoyed over the years including the position paper,

More than just a Bed and our 40th birthday celebration.

In March we welcomed Nancy as the new Secretariat and she has already implemented her own working style in the position. She recently organised a networking day for refuge staff which was very successful. We look forward to continuing working with her.

We would like to say thank you to Koongoora who auspiced the Secretariat wages until March this year. Koongoora organised the payment through their own payroll system for many years and we appreciate their support.

I would like to express my appreciation to all those services and individuals who raised money and collected donations to assist our women and children. Without these, refuges would have found it difficult to meet the needs of our clients.

Last but not least. I would like to say thank you to the members of the Executive Committee for the 2018/19 year which included Mikki, Rosemary, Sue, Cathy, Valda, Karyn, Sue, and Heath. They have worked hard to ensure that the CWRG remains a viable and strong organisation that can continue to support women and children escaping domestic and family violence.


